## **Funding Priorities**

Endowment Investment Growth Sustainable income can be achieved through growth of the Endowment Fund. Spending policy allows 5% of value to be distributed annually. No earnings have been allocated to date. Endowed funds must reach a value of \$500,000 before any distributions of earnings are made. Annual distributions will support Funding Priorities. Funds in perpetuity will work to fill the needs of Oregon Schools for years to come.

#### **Classroom Grant Program**

Since 2000, over \$114,000 has been invested back into Oregon classrooms providing innovative and enriching opportunities in the form of classroom grants.

**Elementary Art Club supplies** Budget cuts eliminated Art instruction for K-4, resulting in the creation of after-school elementary Art Clubs. OSF contributes the supplies.

#### Academics, Arts & Athletics

Targeted Funding has helped provide improvements to specific needs under Academics, Arts and Athletics in all six district schools. OCS Leadership team determines the area of greatest need.

## PLANNED GIVING Provisions

Bequest (Sample Language)

• Unrestricted Gifts: A gift that can be used where need is greatest.

I give, devise, and bequeath to Oregon Schools Foundation, Oregon, Ohio, the sum of \$\_\_\_\_\_\*, for its general purposes.

• Gift for a Specific Purpose: A gift that can be used for a specific purpose.

I give, devise, and bequeath to Oregon Schools Foundation, Oregon, Ohio, the sum of \$\_\_\_\_\_\*, for (state specific purpose, program or activity).

 Residuary Bequest: Leaves any remainder after all other bequests have been made.

I give, devise, and bequeath to Oregon Schools Foundation, Oregon, Ohio, \_\_\_\_\_% of the residue of my estate to be used for its general purposes.

• **Contingency Gift:** Takes effect only if a primary intention cannot be met.

In the event \_\_\_\_\_\_ predeceases me, I give, devise, and bequeath his/her share of my estate to Oregon Schools Foundation, Oregon, Ohio, to be used for it's general purposes.

\*Rather than leaving a sum certain, you may include language that refers to a percentage of your estate or a description of the property you wish to give.
